## Give Where You Live...Yes You Did! Together we raised \$638,198! THANK YOU KEARNEY AREA!

On December 3, the Kearney Area generously showed their support for Give Where You Live by donating more than \$638,198 (52% more than the previous year)! Your generosity significantly helped 146 nonprofits to continue their important work to make our communities stronger.

More than 1,800 unique donors (a 44% increase from 2014) made more than 4156 donations (up 41%) to a variety of causes that improve the quality of life for all of us in Kearney and the surrounding area including Amherst, Axtell, Elm Creek, Gibbon, Pleasanton, Ravenna and Shelton.

The Kearney Area Community Foundation invested \$100,000 in *Challenge Match Funds*, plus \$9500 in bonuses and prizes in order to motivate donors to make the most of their gifts! (Not including costs for promotion or the online platform fee!)

December 3rd was busy throughout the day with events at giving destinations all over the Kearney area including Pleasanton, Ravenna and Shelton.

Your overwhelming response of support helped us to reach our goals for the 2015 Give Where You Live campaign. We set out to raise awareness of our community's current philanthropic needs, cultivate new funding streams and inspire donors to increase their financial support to their favorite local causes as well as finding new ones!


